

Dear Joanne Asadpour:

The Department issued a Flood Hazard Area Individual Permit under DLUR File # 0400-04-0002.1 FHA110002 for activities within the flood plain and riparian zones of Big Timber Creek, Little Timber Creek, and Little Timber Creek Unnamed for the purposes of reconstructing and improving the interchange between I-295, I-76 and Route 46. The applicant had originally requested that the Flood Hazard Area Individual Permit be issued a 10 year permit. The Division of Land Use regulation issued a permit valid for 5 years from the date of issuance, to expire on March 27, 2017. This is an error and the permit should correctly expire March 27, 2022. This applies to the Flood Hazard Area Individual Permit only. Please be advised that the Coastal Wetlands Permit, Freshwater Wetlands Permit and Waterfront Development Individual permits all expire after five years, on March 27, 2017. Please attach a copy of this letter to the original permit.
