Staff comments continued below.

Existing Conditions: U.S. Highway Route 1 (Route 1) is a United States highway which parallels the eastern coastline, running from Key West, Florida in the south to Fort Kent, Maine at the Canadian border in the north. Of the entire length of the route, 66.06 miles of Route 1 runs through the State of New Jersey. Route 1 enters the state from Pennsylvania on the Trenton-Morrisville Toll Bridge spanning the Delaware River in the City of Trenton, running through the city on the "Trenton Freeway." From this point, Route 1 continues in a northeasterly direction as divided highway through Mercer and Middlesex counties, ultimately merging with U.S. Highway Route No. 9 in Woodbridge, after which the two routes continue through northern New Jersey to the George Washington Bridge over the Hudson River in Fort Lee, Bergen County.

Proposed project: The NJDOT proposes to undertake tree trimming activities in the highway right-of-way along U.S. Highway Route No. 1 Trenton Freeway, from the area starting at the point where the highway passes under State Highway Route No. 206 (Broad Street) and proceeding northward to where the highway merges with U.S. Route 1 Business in Lawrence Township, Mercer County.

The applicant indicates that the project would not result in the removal of any trees; but, rather would involve trimming of vegetation and the removal of invasive shrubs. The project would not result in the creation of any impervious surface. To the extent that invasive species would be entirely removed, the project involves "grubbing" activities (the removal of trees, shrubs, stumps and rubbish from a site); however, the applicant has indicated that these activities would not disturb more than one acre of land.

Findings: The applicant proposes an activity within Commission Review Zones A and B. This activity, provided it is not conducted within the boundaries of the Delaware and Raritan State Park, does not meet the definition of a "major project," "minor project" (with respect to those portions entirely within Commission Review Zone A) or "government project" as those terms are defined at N.J.A.C. 7:45-1.3.

However, if the proposed activities are conducted within the boundaries of the Delaware and Raritan Canal State Park, the activities would be a "government project," within Commission Review Zone A and subject to regulation pursuant to N.J.A.C. 7:45-3.6(a), which states in relevant part that "the Commission shall review and either approve, reject or modify each permit or approval to be issued by any State department or agency to any person or governmental entity if the permit or approval involves any portion of the park or any activity therein."

The applicant has not submitted information regarding the specific locations of the proposed activity. Consequently, the Commission staff will not issue a determination **DRCC#:** 19-5455
