#### Preface

A tort is a civil wrong or breach of duty to a person or property for which damages may be claimed as compensation. A tort claim is different from contractual claims made by the Contractor. Contractual claims are to be handled in accordance with the Claims and Contractual Notice procedure as per Subsection 107.12. (See <u>CPH Section IV-C</u>)

- **Note**: The terms "CLAIM" and "NOTICE OF CLAIMS" are reserved for written requests on Department of Treasury Forms filed with the Department of Treasury. They have special significance under the New Jersey Tort Claims Act (Title 59, Chapter 1, et seq.) and improper use of the term may prejudice later defenses if a claim is actually filed. Verbal and written communication of a tort other than on the specific forms are to be referred to as a tort inquiry.
- **Note**: The Contractor and the Contractor's insurance is responsible for all tort claims within the limits of a project from the actual start date until the date of Acceptance regardless of cause, with the exception of Tort claims for accidents associated with snow or ice.

#### **Tort Inquiries**

## 1. Direct Inquiries to the RE

If an inquiry comes directly from an individual, the RE will determine if the incident occurred within the limits of the Construction project.

If the alleged incident occurred within the project limits, the RE will provide the individual with the name of the Contractor and the Contractor's telephone number. The individual will be informed that if the inquiry is not resolved to their satisfaction, they should again contact the RE. However, the RE can only offer assistance in soliciting a prompt response from the Contractor and should make it clear that the State is not in a position to judge the merits of the inquiry. The individual is to be advised that they may protect their rights by filing a claim through the Department of Treasury, Division of Risk Management using the digital claim portal on <a href="https://www.nj.gov/treasury/riskmgt/tort-notice.shtml">https://www.nj.gov/treasury/riskmgt/tort-notice.shtml</a> website by accessing the Tort Claim Login Page (PACFS).

When referring someone to the Department of Treasury, Tort and Contract Unit they should be instructed that their written request indicate as specific a location as possible, the name of Construction project and the name of the Contractor (if applicable). Also, the milepost and /or intersecting street should also be provided.

If it was alleged that there were road deficiencies, and verified by the RE, the RE will

## 2. Inquiries to the Regional Construction Office

The Regional Construction Engineer (RCE) will assign someone (Regional Tort Claims Coordinator) to coordinate tort inquiry investigations and responses.

The Regional Tort Claims Coordinator will refer all inquiries to the appropriate RE based on information provided by the inquirer. It is possible that the RE may not be in Construction and Materials as other units within the NJDOT administer Contracts.

If the Regional Coordinator cannot determine if the issue occurred on a NJDOT project, the inquirer is to be told this and given the option to file a claim directly through the Department of Treasury, Division of Risk Management using the digital claim portal on <u>https://www.nj.gov/treasury/riskmgt/tort-notice.shtml</u> website by accessing the Tort Claim Login Page (PACFS).

## 3. Written Tort Inquires

Written communication received from other than the Department of Treasury (or their third party claims administrators) inquiring about a tort against the Department or any of the Department's employees, regardless of the claim submitted, shall be referred to <u>https://www.nj.gov/treasury/assets/contact/riskmgt/contact-riskmgt.shtml</u> or

## Tort Claims

## 1 Tort Claims Forwarded from Division of Risk Management

The RCE will assign someone (Regional Tort Claims Coordinator) to coordinate tort claim investigations and responses.

The Department of Treasury, Division of Risk Management or the Department of Treasury's third party claims administrators may send a letter or email requesting an investigation of a tort claim.

The Regional Tort Claims Coordinator will investigate and identify any claims for which the

tort occurred within the limits of a Construction project, and forward applicable claims to the RE. (See Attachment "A")

The RE will respond directly to the requesting agency, confirming that the tort occurred within the limits of the Construction project. (See Attachment B) The RE will also provide a copy of the Contract and a copy of the Insurance Certificate, Form DC-175, applicable for the date in question. (Refer to CPH Section III-D) A copy of the response will be forwarded to the Regional Tort Claims Coordinator.

If a claim cannot be identified because of incomplete information, the Regional Tort Claims Coordinator will respond to the requesting agency accordingly. (See Attachment "C") **NOTE**: Tort claims may be associated with projects administered by Operations.

If a claim identified as not being associated with a Construction project administered by the Region, the Regional Tort Claims Coordinator will respond to the agency accordingly and forward the letter to the Regional Maintenance Engineer. (See Attachment "D")

The Regional Tort Claims Coordinator will maintain a log noting the disposition of all tort claims and responses. (See Attachment "E") Responses to the requesting agency will be made within 15 days from their initial receipt by the Regional Office.
