# Route 10 overnight closures at New Murray Road as intersection improvement project begins in East Hanover Traffic to be detoured tonight and tomorrow night

**(Trenton)** – New Jersey Department of Transportation (NJDOT) officials today announced overnight closures and detours on Route 10 tonight and tomorrow night as an intersection improvement project begins in East Hanover, Morris County.

# Tuesday, August 23

Beginning at 10 p.m. tonight, Tuesday, August 23, until 5 a.m. tomorrow, Wednesday, August 24, NJDOT's contractor, Joseph M. Sanzari, Inc., is scheduled to close and detour Route 10 eastbound at New Murray Road to install mast arms for a new traffic signal. If overnight work is completed sooner the intersection will reopen earlier. The following detour will be in place:

## Route 10 eastbound at New Murray Road detour:

- Motorists on Route 10 eastbound will be directed to take the exit for River Road and Okner Parkway, which becomes Mount Pleasant Avenue
- Turn left onto River Road
- Turn right onto Route 10 eastbound

## Wednesday, August 24

Beginning at 10 p.m. tomorrow, Wednesday, August 24, until 5 a.m. Thursday, August 25, Route 10 westbound will be closed and detoured at New Murray Road to install mast arms for a new traffic signal. If overnight work is completed sooner the intersection will reopen earlier. The following detour will be in place:

## Route 10 westbound at New Murray Road detour:

- Motorists on Route 10 westbound will be directed to take the All Turns exit at Office Tavern & Grill/Marshalls
- Turn right onto New Murray Road northbound
- Turn left onto Murray Road westbound
- Turn left onto Ridgedale Avenue southbound
- Turn right onto Route 10 westbound

The work is part of a \$5.2 million federally-funded maintenance project to make safety and operational improvements at twelve intersections on Route 10 between Harrison Avenue in Morris Plains, Morris County and West Northfield Avenue in Livingston, Essex County. Improvements include new ADA compliant ramps, traffic signal upgrades with pedestrian pushbuttons, highway lighting modifications, and crosswalk striping. The project is expected to

be completed fall of 2024. The precise timing of the work is subject to change due to weather or other factors.
